The Government of the Republic of Maldives through the Ministry of Environment, Climate Change and Technology (MECT) is implementing “Water Supply Systems” financed by Green Climate Fund (GCF) and intends to apply part of the proceeds for the services of a full time Project Coordinator (PC) to assist the water projects administered by the Ministry of Environment in collaboration with United Nations Development Project (UNDP).

The objective of this assignment is operational management of the projects in accordance with the project documents and as per the GCF guidelines in collaboration with the project team and stakeholder agencies to ensure all implementation arrangements of projects are carried out smoothly and on time.

The Ministry of Environment, Climate Change and Technology (MECT) now invites interested eligible individual consultants to submit their application.
