The Government of Republic of Maldives represented by Ministry of Environment, Climate Change and Technology has received financing from the Green Climate Fund (GCF) for the project to Support vulnerable communities in Maldives to manage climate change-induced water shortages, and intends to apply portion of the financing for eligible payments under the contract for the project Supply and Installation of Infiltration systems at 08 Islands RWH Treatment Site (Aa. Bodufulhadhoo, Adh. Dhigurah, Th. Kandoodhoo, Th. Dhiyamigili, M. Nalaafushi, Dh. Meedhoo, Ga. Nilandhoo and Gdh. Rathafandhoo)". The Ministry now invites sealed bids from eligible and qualified bidders for this project.

The bidder shall be a Registered in National Contractors Registry.

Late bids will be rejected.
