1. Introduction

This user guide has been developed for the implementation of Hakathari Label based procurement as per the notification from the Ministry of Finance under the clause 10.77 of the 3rd Amendment (2020/ R-51) to PFR 2017/R-20.

The user guide should be followed when procuring air conditioners, refrigerators and washing machines. Only Hakathari labelled appliances with minimum 4-star rating are eligible for procurement. The Hakathari labelled appliances covered under the Hakathari Program – Energy efficiency standards and labelling program of the Maldives are as follows:

- 2. Preparation of the bid documents including the list of parameters and evaluation criteria to be included in the bid.




The Hakathari Label will be affixed on the models that has been registered under the Hakathari Program – Energy efficiency standards and labelling program of the Maldives.



3.3. Documents to be submitted by Bidder

The following documents shall be submitted by the bidder for verification of information provided:

- 1. Declaration of conformance to the Hakathari Labelling Program (Energy efficiency standards and labelling program of the Maldives) as provided in section 5.
- 2. Product catalogue including product model number.
- 3. Signed and sealed 'Bidder technical details submission form' refer section 4.3.

3.4. Evaluation criteria

The bid shall be checked to meet the following criteria:

- 1. Should be 4 Star or higher Hakathari Labelled appliance.
- 2. Should meet the requirements criteria as mentioned in the section 4.1.

The bids that meet the above criteria shall be evaluated based on least cost offer (Acquisition costs+ Installation costs).

Sample format to be used in the bid document is provided in section 4.

The procuring entity should include the sections 4.1, 4.2 and 4.3 as part of the bid documents.

- 1. Should be 4 Star or higher Hakathari Labelled appliance.
- 2. Should meet the requirements criteria as mentioned in the section 4.1.

The bids that meet the above criteria shall be evaluated based on least cost offer (Acquisition costs+Installation costs).
