

## **Executive summary**

This report has been commissioned as part of the Capacity Building Initiative for Transparency (CBIT) project, funded by the Global Environment Facility (GEF). It aims to address the gaps and needs highlighted in the 1st Biennial Update Report (BUR1) and establish a robust monitoring, reporting, and verification (MRV) system for monitoring climate change impacts and adaptation.

The thematic focus of the report is adaptation monitoring, involving data collection, analysis, and reporting on risks, vulnerabilities, policies, measures, and actions that reduce the harmful impacts of climate change. It outlines the expected outputs from the MRV system, such as expert reviews, data sets, and indicators, contributing to various domestic and international reports and strategies, thereby supporting transparency in climate change adaptation efforts.

The report reviews the institutional framework for monitoring adaptation actions across governance, expertise, data flows, tools, and stakeholder engagement, examining legal arrangements and potential data collection bottlenecks. It lays the groundwork for a comprehensive MRV system to support informed decision-making on climate action, policy, and investment. The report proposes a detailed list of recommendations to support the list of recommendations provided for the stocktaking exercise on the Maldives' national NDC and climate mitigation tracking system.

Key findings and recommendations under each of the components of the institutional framework are summarized and outlined below.

#### Governance

- 1. There's a significant need for a Coordination Framework that clearly outlines the roles of individual data-providing line ministries, and local/island level organizations, including the monitoring and reporting of sectoral indicators, policies, and measures for adaptation NDC target tracking.
- 2. Climate adaptation is not fully integrated into sectoral, local, and island-level development planning, which requires a clear division of labor across policy planning, implementation, monitoring, evaluation, budgeting, and financing strategies to ensure alignment with the NDC, building on existing mainstreaming efforts like the Health National Adaptation Plan.
- 3. The Climate Change Act mandates the formation of an 'independent institution" with the purpose "to strengthen financial monitoring of funds received by the Maldives from national and international sources to mitigate climate change effects, improving climate adaptation, to achieve the target of establishing the Maldives as a carbon neutral country, and to protect and maintain the environment". However, engagement with this proposed independent institution for strengthening financial monitoring is lacking, which is necessary to clearly identify and tackle financial gaps in adaptation planning, implementation, monitoring, and evaluation.

#### **Key Recommendations:**

#### 1. Coordination Framework development

- Develop adaptation specific Coordination Framework and data collection plans for indicators, policies and measures with supporting regulations, Memorandums of Understanding (MoUs) or data sharing agreements as needed.
- Establish the roles of the steering committee and technical committees in guiding regular policy planning, data collection, reporting, monitoring and evaluation.

#### 2. Mainstream climate adaptation into sectoral, local and island level planning.

 Incorporation in Sectoral Planning: Perform a climate adaptation activity screen during the sectoral action plan development, for instance, in the agricultural sector, this could involve adjusting agricultural practices and crop selections based on projected climate impacts,

- ensuring that all agricultural development plans include strategies for climate resilience and emission reductions.
- Local and Island Level Development: At the local and island level, urban planning guidelines should be revised to incorporate climate risk assessments, ensuring that infrastructure projects, such as roads and buildings, are designed to withstand predicted climate conditions like increased flooding or higher temperatures.
- Monitoring and Evaluation Protocols: Establish standardized climate-related indicators across
  all sectors to measure the effectiveness of integrated strategies and ensure continuous
  improvement. For example, monitoring the reduction in carbon emissions in the transport
  sector or assessing the effectiveness of newly implemented coastal protection measures.
- Budgeting and Financing: Allocate specific budget lines for climate adaptation and mitigation measures within each sector's annual budget. This could include funding for renewable energy projects in the energy sector or for water conservation technologies in water resource management.
- The formation and regular engagement of the steering committee and technical committees should support this process and clearly communicate priorities from CCD based on ongoing tracking of adaptation targets.

#### 3. Adaptation financing strategy

 Track and monitor the implementation of the INFF alongside independent institution mandated by the Climate Emergency Act, DCC and line ministries to strengthen financial monitoring.

#### **Expertise**

#### **Key Findings:**

1. Capacity building is required to develop national expertise in performing risk and vulnerability assessments and in assessing climate action vulnerability reduction impacts.

#### Key Recommendations:

#### 1. Development of national expertise:

- Identify national expert teams responsible for carrying out risk and vulnerability assessments and assessing climate action vulnerability reduction impacts.
- Carry out a training program on climate modelling, risk and vulnerability assessments.
- o Carry out a training program on assessing climate action vulnerability reduction impacts.

#### **Data flows**

#### **Key Findings:**

- The lack of an institutionalized system for collecting and ensuring the quality of climate data (e.g. on risks, vulnerabilities, impacts and actions) is hindering decision-making and sector-specific risk assessments.
- 2. There are challenges with quantifying adaptation needs and current levels of investment in adaptation action at the local level to effectively understand the scale of requirements for adaptation action.

#### **Key Recommendations:**

#### 1. Development of institutionalized system for collecting climate data

- Develop detailed list of SMART indicators (minimum one per adaptation target in the NDC)
- o Build database of climate adaptation targets, challenges, actions and indicators.

- Establish a coordination framework with a data collection plan, standardized data formats and protocols for collecting information on climate impacts and climate action outcomes.
- 2. **Carry out training programs** at the local level on data collection methodologies, use of technology for data gathering and analysis, and understanding of climate adaptation needs and strategies.

#### Systems and tools

#### **Key Findings:**

- There is a need to standardize data collection and reporting through the use of common tools and templates. These templates should be integrated with any existing systems such as the DesInventar database.
- 2. Implementation of any new tools or templates must be supported by experts who have received extensive training. These systems should also capture key lessons learned and track national improvement plans.

#### **Key Recommendations:**

#### 1. Standardized data collection and reporting tools

- Develop data collection templates for climate impacts and climate adaptation action reporting.
- Develop adaptation target tracking database system that includes mechanisms for data processing, archiving and storage.

#### 2. Develop training program and improvement plan

- Deliver comprehensive training on data collection, processing, management and reporting tools
- Develop national improvement plan and tracking tools.

#### Stakeholder engagement

#### **Key Findings:**

1. Data is made available to the public and decision makers on request but as discussed above, a lack of capacity at local level limits communication and coordination on adaptation needs and investment requirements.

#### **Key Recommendations:**

1. **Develop communication plan** to coordinate regular, schedule communication on progress, challenges and needs for adaptation impact tracking.

#### Introduction

This report is part of the Capacity Strengthening for Improved Transparency of Climate Change Mitigation and Adaptation Actions in the Maldives project, under the Global Environment Facility (GEF) funded Capacity Building Initiative for Transparency (CBIT) program. The objective of this report is to conduct a stocktaking exercise to identify gaps with respect to the legal arrangements, mandates and institutional framework for adaptation monitoring.

This report will review the institutional framework for monitoring risks, vulnerabilities and adaptation actions through five components: governance, expertise, data availability and flows, systems and tools and stakeholder engagement. This will include a review of the relevant legal arrangements and mandates for collecting relevant information on national adaptation efforts.

The development of a well-functioning MRV system will help the Maldives to track adaptation outcomes such as those in the updated NDC and National Adaptation Plan (NAP).

The findings from this report will serve as the basis for the recommendations and improvement actions described in the Enhanced Transparency Framework (ETF) Roadmap (Deliverable 2.1.2). The report is structured as follows:

- An overview of the MRV System design with respect to the scope, outputs and data types covered.
- Comprehensive stocktaking review of the institutional framework for monitoring adaptation action
- Key gaps and barriers described, including any potential bottlenecks in the legal arrangement.

## MRV system concepts

This section introduces concepts for the development of an MRV system, for a full detailed description of the MRV concepts, refer to the Report on Gaps and Needs and Institutional Arrangements for the Monitoring of Mitigation Actions. Through the implementation of the CBIT project, the Maldives will develop a sustainable MRV system that will enable it to track progress towards a range of adaptation, mitigation and climate finance targets and contribute to a range of different outputs and communications using well understood terms and indicators.

The analysis draws on a range of recent reports and ongoing work specifications and reports that relate directly or indirectly to the development of an MRV system including:

- Key international climate change reports (e.g. BUR1, 2<sup>nd</sup> National Communication (NC2), NDC)
- National development strategies (e.g. Strategic Action Plan 2019 2023, Low Carbon Development Strategy, Climate Change Policy Framework)
- Ongoing and complete project documents (e.g. GCF Readiness Proposal for Advancing the National Adaptation Plan)
- Documentation of government institutional arrangements and existing data flows.

A full list of the documents reviewed for this project is included in Appendix 1.

### Scope

The scope of this report is adaptation monitoring. In line with the Paris Agreement Modalities, Procedures and Guidelines (MPGs) for reporting under the Enhanced Transparency Framework (ETF), the full scope of adaptation monitoring includes:

• Current and projected climate trends and hazards

- Observed and potential impacts of climate change
- Loss and damage
- Adaptation priorities and barriers
- Adaptation goals, actions, objectives, undertakings, efforts, plans (e.g. national adaptation plans and subnational plans), strategies, policies, priorities (e.g. priority sectors, priority regions or integrated plans for coastal management, water and agriculture), programs and efforts to build resilience.
- Adaptation implementation progress
- Monitoring and evaluation of adaptation actions and processes

Given the broad range of disciplines involved in adaptation monitoring, a comprehensive institutional framework are required with well-resourced experts across different sectors with access to high quality data.

#### Outputs

Reporting on adaptation monitoring includes a range of domestic and international outputs. These outputs include:

- Reporting on climate change impacts and adaptation in the Biennial Transparency Reports and National Communications (non-mandatory)
- NDC tracking and updates.
- Updates to national policies and strategies such as the National Adaptation Plan, and the draft Strategic Action Plan (SAP) 2024–2028 (under development).
- Sectoral programs and initiatives such as GEF-financed project Increasing Climate Change Resilience of Maldives through Adaptation in the Tourism Sector Project and Health National Adaptation Plan.
- Adaptation related planning and funding documents including Project Identification Notices (PINs), proposals and concept notes for long term programmes such as the GCF-country programme and adaptation pipeline development work under the NDC Partnership's Partnership Action Fund (PAF).
- Subnational level strategic development plans such as the Island Land-use and Development Plans which are informed by adaptation resilience data.

Engagement with these outputs requires a consolidated effort to track and manage adaptation data by well resources experts.

# Challenges, targets, actions, indicators


The MRV system will help stakeholders identify and track a range of climate related **targets** (such as those in the NAP and NDC), **actions** (policies, measures, projects, initiatives), and **indicators** to track the progress of both. The structure of this data is similar to the data structures used to track progress of mitigation actions and targets. However, adaptation efforts also require a more detailed view of the **challenges** presented by climate change (current and projected climate trends and hazards, observed and potential impacts of climate change, loss and damage). These challenges are the drivers for enhanced ambition and actions to increase resilience. A comprehensive understanding of the challenges is also needed to communicate financial, technological and capacity building needs to the international community for support with implementation of adaptation action.

The sections below illustrate examples of these data types and their relevant for adaptation monitoring.

#### Challenges

Understanding the threats and challenges enables the MRV system to support decision makers with justification for actions. Describing the challenges in narratives and presenting indicators on challenges (e.g. numbers of severe weather events and their impacts) focus stakeholders on the call to action and provide

transparent evidence on the problems. Challenges include climate risks and vulnerabilities, which lead to impacts, and, ultimately, loss and damage. Any step along this process can be classified as a challenge and can be used to justify the development of targets, policies and measures that reduce risk and/or vulnerability, limit the impacts of climate change or avoid/minimize loss and damage. The figure below illustrates the role of identifying challenges in addressing and reducing climate impacts, loss and damage.



Information on challenges can be structured and maintained in the MRV system to support consistent communication between stakeholders. These challenges can be specific to organization, sector, time and geography. Areas of challenges relevant to the Maldives, include<sup>1</sup>:

- Threats to human life due to increased prevalence of severe and extreme weather events.
- **Economic losses to the fishing and tourism industries** due to ocean acidification, sea temperature rise and coral reef bleaching.
- Land loss, economic loss and damage to low lying infrastructure due to sea level rise.
- Threats to limited freshwater resources due to sea level rise and increased rainfall variability.
- Reduction in agricultural crop yields due to increased rainfall variability and sea level rise.
- Increased risk to food storage and distribution facilities due to severe and extreme weather events.
- Increased threats to human health from vector borne diseases due to increased prevalence of climate extreme and El Niño-Southern Oscillation (ENSO) events.
- Soil surface temperature and increased pest prevalence due to temperature fluctuations and increases in average temperatures.
- Soil erosion due to extreme wind speeds and weather events.

The national MRV system should be aware of the relevant challenges, track them and link them to targets, actions and indicators. The list above is not exhaustive and should be developed in full through vulnerability assessments for the MRV system.

#### **Targets**

Adaptation targets cover a wide range of subject matters and are far less standardized than climate mitigation targets. The ultimate goal of all adaptation targets is to increase resilience and reduce vulnerability from climate change impacts. Adaptation targets often rely on policies and measures-based approaches to achieve their goals. Broadly, adaptation targets fall under one of a few types:

- **Strengthening legislative frameworks** to integrate climate change adaptation efforts into mainstream national development planning.
- Increasing resilience/climate proofing land areas or infrastructure.
- Increasing human and technical capacity to plan and respond to climate change impacts.
- **Developing financial mechanisms** to better equip institutions and sectors to deal with climate change impacts.
- Developing and improving technologies to better track climate trends, risks and impacts.

The targets extracted from the Maldives' NDC have been categorized based on the types of targets above and are provided in the table below. Some of these targets include elements or approaches that cross-cut multiple target types, in these cases the most appropriate target type has been selected.

Continue strengthening and expansion of the meteorological network and early warning systems to cover the entire archipelago.  Improve the climate and weather forecasting tools for decision making. In addition to the NDC, it is important to consider other sectoral strategies or national development plans, such as the NAP, to ensure the targets and ambitions are aligned across the mandates of different stakeholder organizations.

#### **Actions**

The Actions list will detail various projects and programs and initiatives, focusing on adaptation, reducing vulnerability, loss and damage and increasing resilience. The NAP Readiness Proposal and NC2 include details of planned, ongoing and implemented climate change adaptation actions, some examples are listed below:

- **Tourism:** Increasing Climate Change Resilience of Maldives through Adaptation in the Tourism Sector Project (TAP).
- Fisheries: Multi-species hatchery program under the IFAD-Mariculture Enterprise Development Project
- Agriculture and food security: initiative to introduce hydroponics as an alternative production technology on land scarce islands to further increase food security; integrated farming project using greenhouse auto-pot systems.
- Water: Improve access to desalinated or rainwater-piped water and sewage systems across several islands; Increasing climate resilience through Integrated Water Resource Management.

As with climate mitigation actions, developing a live database on climate actions is a vital step to assessing progress against targets, to see which sectoral targets need further attention, any barriers or constraints and what the support needs are to achieve those targets. This is particularly important for adaptation, where the targets are primarily policies and measures based which need urgent attention in addressing.

Since there is no defined reporting format in the Paris Agreement MPGs on adaptation actions, a tabular format designed around domestic needs can be adapted. However, for consistency and cross-sectoral collaboration, a hybrid table that captures information on mitigation and adaptation actions is recommended.

#### **Indicators**

Quantitative or qualitative indicators are important to monitor and track the progress of adaptation targets. Indicators should be specific, measurable, ambitious, relevant and time-bound (SMART) to ensure it is feasible to track progress with them. For adaptation, indicators may relate to a specific policy or measure (tracked qualitatively e.g., with a description of progress or assessment of increased capacity, or quantitatively e.g. number of climate-resilient technologies implemented), and they may track adaptation outcomes e.g. change in yield reduction or in projected vulnerability. In the absence of data, percentage target progress based on expert judgement may be used as an interim measure but should be supported with clear explanations and justifications. Under adaptation, indicators are also used to track climate risks, vulnerability and adaptive capacity, i.e. to monitor the progress of the **challenges**. For example, the United Nations Statistics Division Global Set of Climate Change Statistics and Indicators<sup>2</sup> lists many climate risk and vulnerability indicators such as crop loss due to climate extremes or reduction of surface water bodies.

Example indicators suggested from an analysis of the NDC adaptation targets could include:

#### Outcome related indicators:

- Hectares of mangrove ecosystems conserved or restored annually.
- Coral reef species richness and diversity
- Access to safe drinking water

Fishing stock biomass

Specific policy or measure related indicator:

- Percentage increase in agricultural areas applying climate smart IPM strategies annually.
- Number of IWRM systems implemented and operational within communities.
- Amount of finance (USD) accessed by small-scale fishers and fishing communities annually for vulnerability reduction and sustainable practices.

The development of a full set of indicators is planned under the CBIT (for agriculture sector) and NAP (all remaining sectors) projects.

#### Institutional Framework

Successful MRV of climate change adaptation requires consideration of five components for a strong institutional framework:

- 1. **Governance** such as roles, responsibilities, agreements, laws, and commitments
- 2. **Expertise** including data, modelling, compilation, and reporting experts across a range of themes.
- 3. Data flows and availability of the data necessary for the MRV system to be of value.
- 4. Systems and tools for information, communication, and engagement
- **5. Stakeholder engagement** to effectively communicate the value of the data.

These components will cover a range of formalities and activities across several organisations. These organisations might include government ministries and/or agencies, academic/research institutions, local self-government, private organisations, and consultants. A well-functioning institutional framework will ensure that the MRV system can fulfil the commitments set out in national strategic plans. They will be flexible and sustainable and ensure that resources are available for recurring and continuously improving data gathering, compilation, analysis and reporting across the agreed scope. These components should be used to assess current institutional framework and be used as a foundation for future MRV development.

The sections below present the results of the stocktaking exercise on each of these components using a desk-based review and limited stakeholder survey. Each component is presented with a set of key recommendations, many of these recommendations have already been proposed to be addressed through the CBIT or NAP capacity building activities. They have been highlighted in green or blue if they align with existing activities under the CBIT or NAP projects respectively.

#### Governance

Governance refers to the roles, responsibilities and legal arrangements that mandate and support regular and reliable reporting on climate adaptation. The governance related gaps and barriers identified in key document review included:

- 1. Weak institutional and coordination mechanisms for planning climate change adaptation<sup>3</sup>:
  - a. A lack of a capacitated intersectoral management structure has also created gaps, overlapping mandates and weak inter-sectoral coordination amongst the institutions and sectors facing climate change impacts.

- 2. Lack of systematic integration of CCA into national, island and sectoral development planning and budgeting processes<sup>4</sup>:
  - a. Adaptation inconsistently mainstreamed into sectoral planning and in silos (often based on incomplete or limited vulnerability assessments).
  - b. Lack of coordination between ministries in developing annual and three-year development budgets, as well as a lack of effective collaboration during policy framing have led to difficulty in implementing such policies<sup>5</sup>.
  - c. The intended mainstreaming of CCA planning into key national policies under the Integrating Climate Change Risk into Resilient Island Planning in the Maldives (ICCRRIP) project was incomplete, with the 'Coastal Protection Regulation' developed only in draft form but not sent for approval or formally adopted or implemented and guidelines being only partially drafted, with limited distribution.
- 3. Limited and uncoordinated access to financing to reduce vulnerability and increase adaptive capacity<sup>6</sup>:
  - a. A lack of funds and access to financing for projects to reduce vulnerability and increase adaptive capacity has been cited as an issue, this may be mitigation however by the recent development of the Maldives Integrated National Financing Framework (INFF).

The Ministry of Climate Change, Energy and Environment (MCCEE), and CCD in particular, is the key government institution managing climate change adaptation efforts and also serves as the National Designated Authority to the Green Climate Fund (GCF) and NAP implementation agency. The NAP Readiness Proposal (2020) presents a view of current roles and responsibilities besides the CCD related to the implementation of the NAP:

- Ministry of Finance (MoF) concerning budgetary planning and aid coordination;
- Ministry of Construction and Infrastructure (MCI) concerning overall national planning and infrastructure adaptation;
- Ministry of Home Affairs (MoHA), and Local Governance Authorities (LGAs) concerning subnational governance of local islands and atolls;
- Ministry of Gender, Family and Social Services concerning gender-responsive development and the inclusion and empowerment of women and vulnerable groups;
- Ministry of Tourism (MoT) concerning adaptation regulation in the tourism sector;
- Ministry of Transport and Civil Aviation (MTCA) concerning transportation systems and infrastructure adaptation;
- Ministry of Agriculture and Animal Welfare, and the Maldives Food and Drug Authority (MoFMRA) concerning food security and agriculture.
- Ministry of Fisheries and Ocean Resources? Marine resources planning, fisheries sector adaptation
- Ministry of Health, and the Health Protection Agency concerning adaptation in the health sector;
- Maldives Meteorological Services (MMS) concerning the aggregation and dissemination of climate information and services, early warning?;
- National Bureau of Statistics concerning adaptation-related socio-economic data collection and management;

- National Disaster Management Authority concerning disaster risk reduction; and national utilities
   concerning energy and water security, loss and damage data?
- Environmental Protection Authority (EPA) primary data collection for adaptation indicators and conducting research on beach erosion, biodiversity management and protected area management.
- Atoll Councils and Island Councils providing support to the Project Management Unit with island-level governance mechanisms and in monitoring the activities at island and atoll level.

The project related institutional framework also proposes the following bodies are created to support NAP implementation:

- **Steering Committee** high level representatives from relevant line ministries. Mandated to formulate and implement the policies, programmes and projects identified in the NAP.
- CSO/NGO Advisory Committee representatives from the private sector, civil society and academia, ensuring that women's and marginalised people's interests and perspectives are included in decisionmaking. The CSO/NGO Advisory Committee will support the Steering Committee in its mandate and with validating any sectoral plans, policies, programmes and projects.
- **Technical Committee** chaired by the UNFCCC focal point. To provide technical guidance and ensure communication and reporting on the NAP process with national and international adaptation communities.
- Project Management Unit including a NAP project manager, Admin and Finance Officer and a Gender specialist. Day to day management of the NAP process.

Based on these existing, project-based arrangements for the implementation of the NAP, a set of adapted formal, permanent roles and responsibilities are proposed in the diagram below, this also includes roles for supporting agencies including the Environmental Protection Agency (EPA), Utilities Regulatory Authority (URA), and Biosphere Reserve Office (BRO). These are also proposed in parallel with the institutional framework proposed in the mitigation stocktaking report with some overlapping elements such as the MRV Steering Committee.




Figure 1. MRV of adaptation monitoring - proposed structure

The key legislation related to adaptation monitoring MRV system is the Climate Emergency Act 09/2021. An analysis of this legislation is presented in the table below.

There is a distinction between publishing climate change effects statistics (Chapter 3, para 18.w)) and reporting on progress of NDC targets. As such the identification of NDC target specific indicators should be mandated by the supporting regulations under this Act.

Importantly, the roles of individual line ministries, and local and island level government organizations are not defined and should be included as part of supporting regulations.

The proposal of an independent institution to strengthen financial monitoring (Chapter 6, para 23.a). intends to address the gap identified in the NAP Readiness proposal: "Limited and uncoordinated access to financing to reduce vulnerability and increase adaptive capacity".

Sectoral legislation for adaptation monitoring is patchwork, more so than for data relevant to mitigation efforts. For example, the Fisheries Act which strengthens governance of this sector, and the National Water and Sewerage Policy which aims to support management of water resources in the Maldives however does not directly address considerations to directly address the impacts of climate change on water supply or access.

The 2019-2023 Strategic Action Plan (SAP), although not legislative, does include provisions to support sectoral adaptation planning. For example, the Resilient Communities priority sector which looks to reduce risk and increase resilience with a wide range of strategies and actions, the Blue Economy priority sector which includes adaptation goals in the tourism, fisheries, agriculture, as well as including water and sanitation and health separately.

The key findings on governance are as follows:

- 1. There is a strong need for a Coordination Framework that clearly defines the roles of individual data providing line ministries, and local/island level organizations.
  - a. This should identify which sectoral indicators, polices and measures need to be monitored and reported to support adaptation NDC target tracking.
  - b. This should formalize data collection plans, any data gaps and needs, a data reporting schedule and standardize data formats.
- 2. Climate mainstreaming into sectoral, local and island level development planning should be completed, with clear division of labor on policy planning, implementation, monitoring and evaluation, budgeting and financing strategy. This should ensure alignment across sectoral strategies and action plans with the NDC. This approach should build on previous mainstreaming activities, such as those outlined in the Health National Adaptation Plan, which integrates climate resilience measures into public health infrastructure, ensuring that healthcare facilities are equipped to handle increased climate-related health issues.
- 3. Further engagement with the proposed independent institution and implementing line ministries to strengthen financial monitoring is needed to implement the outlined action plan in the INFF and address financial gaps related to adaptation planning, implementation, monitoring and evaluation.

#### **Key recommendations:**

#### 4. Coordination Framework development

- Develop adaptation specific Coordination Framework and data collection plans for indicators, policies and measures with supporting regulations, Memorandums of Understanding (MoUs) or data sharing agreements as needed.
- Establish the roles of the steering committee and technical committees in guiding regular policy planning, data collection, reporting, monitoring and evaluation.

#### 5. Mainstream climate adaptation into sectoral, local and island level planning.

- Incorporation in Sectoral Planning: Perform a climate adaptation activity screen during the sectoral action plan development, for instance, in the agricultural sector, this could involve adjusting agricultural practices and crop selections based on projected climate impacts, ensuring that all agricultural development plans include strategies for climate resilience and emission reductions.
- Local and Island Level Development: At the local and island level, urban planning guidelines should be revised to incorporate climate risk assessments, ensuring that infrastructure projects, such as roads and buildings, are designed to withstand predicted climate conditions like increased flooding or higher temperatures.
- Monitoring and Evaluation Protocols: Establish standardized climate-related indicators across all sectors to measure the effectiveness of integrated strategies and ensure continuous improvement. For example, monitoring the reduction in carbon emissions in the transport sector or assessing the effectiveness of newly implemented coastal protection measures.
- Budgeting and Financing: Allocate specific budget lines for climate adaptation and mitigation measures within each sector's annual budget. This could include funding for renewable energy projects in the energy sector or for water conservation technologies in water resource management.
- The formation and regular engagement of the steering committee and technical committees should support this process and clearly communicate priorities from CCD based on ongoing tracking of adaptation targets.

#### 6. Adaptation financing strategy

 Track and monitor the implementation of the INFF alongside independent institution mandated by the Climate Emergency Act, DCC and line ministries to strengthen financial monitoring.

#### Expertise

Expertise refers to the team of national experts who should be capable of regularly gathering and processing data in order to produce the agreed outputs in a timely manner. The team should have suitable back-up expertise and access to relevant training materials. There should also be effective recruitment, retention and succession procedures in place that motivate the long-term and active involvement of experts in the reporting process. The expertise related gaps and barriers identified in the key document review included:

- Limited capacity for planning CCA, including limited technical capacity to assess climate risk vulnerability or appraise adaptation measures<sup>7</sup>:
  - Adequate strategies and technical capacity for undertaking the NAP process are lacking for MECCT.
  - Elevated staff turnover in key ministries has eroded institutional knowledge over time —
    particularly regarding technical capacity to conduct data collection, analysis/interpretation
    and research.
- Specific capacity building needs identified in the BUR1 included:
  - Enhancing weather and climate monitoring in the Maldives and developing human resource capacity at Maldives Meteorological Service
  - Coastal Protection and Institutional strengthening for coastal monitoring
  - Assessment of vulnerabilities and risk reduction of health sector to vector borne diseases due to climate change impacts
  - o Strengthening Health Sector Emergency Response to floods and sea swells.
  - Establishing GIS Integrated national level systems for disaster management information, communication and coordination.
  - Assessment of health risks due to air pollution
- Limited number and sometimes capacity of local experts to develop and implement projects which are acceptable to international climate finance sources, such as the GCF.<sup>8</sup>
- Severe shortage of skilled and professional staff within the climate change sector, and limited knowledge and technical know-how about climate risk management and climate change adaptation more generally across all sectors, particularly about specific adaptation options suitable for the Maldives.<sup>9</sup>
- There is a need to continue the national capacity building programs with assistance from the
  international community, develop and promote appropriate technologies to address climate change
  impacts with support from the international community and develop appropriate policy and
  strategies to address the impacts of climate change on vulnerable groups<sup>10</sup>.

The key findings from the stakeholder survey (see Appendix 2. Stakeholder Survey Results) on expertise are that:

1. Capacity building is required to develop national expertise in performing risk and vulnerability assessments and in assessing climate action vulnerability reduction impacts.

#### **Key recommendations:**

#### 2. Development of national expertise:

- o Identify national expert teams responsible for carrying out risk and vulnerability assessments and assessing climate action vulnerability reduction impacts.
- o Carry out a training program on climate modelling, risk and vulnerability assessments.
- o Carry out a training program on assessing climate action vulnerability reduction impacts.

#### Data flows

Reliable, regular data flows are essential for a well-functioning institutional framework and the delivery of a national transparency framework. This includes defining the need for and uses of data, managing the delivery of the required datasets from a range of data providers on a regular basis and continuously improving data and reducing uncertainty. Identifying and engaging with stakeholders who hold, produce and could supply this data will be important. DSAs will be important for securing reliable data flows. The data flow related gaps and barriers identified in the key document review included:

- Limited access to, and sharing of, reliable climate change information and knowledge for decisionmakers and stakeholders<sup>11</sup>:
  - Much of the climate information and sector-specific risk assessments are inconsistent, outof-date or at ineffective scales.
  - Poor quality of available sectoral data identified as a barrier for developing the vulnerability assessment.
  - Lack of an institutionalized data collection and quality control system leads to poor data quality and inconsistent data formats.
- Data gaps and capacity constraints at local level pose severe challenges to sufficiently quantify
  adaptation needs at the local level as well as understand current investment in adaptation. Hence
  there is limited understanding of the scale and magnitude of these needs.<sup>12</sup>

The key findings on data flows from the stakeholder survey (Appendix 2. Stakeholder Survey Results) are that:

- 1. The lack of an institutionalized system for collecting and ensuring the quality of climate data (e.g. on risks, vulnerabilities, impacts and actions) is hindering decision-making and sector-specific risk assessments
- 2. There are challenges with quantifying adaptation needs and current levels of investment in adaptation action at the local level to effectively understand the scale of requirements for adaptation action.

#### Key recommendations:

- 3. Development of institutionalized system for collecting climate data
  - Develop detailed list of SMART indicators (minimum one per adaptation target in the NDC)
  - o Build database of climate adaptation targets, challenges, actions and indicators.

- Establish a coordination framework with a data collection plan, standardized data formats and protocols for collecting information on climate impacts and climate action outcomes.
- 4. **Carry out training programs** at the local level on data collection methodologies, use of technology for data gathering and analysis, and understanding of climate adaptation needs and strategies.

#### Systems and tools

Systems and tools are important for the smooth functioning of the transparency system. This encompasses managing the collection, analysis, QA/QC, summarizing and archiving of data and the preparation of briefings and reports. Institutional arrangements need to provide for the development and maintenance of workplans, engagement tools, databases, data collection and data analysis tools, indicators and reports. The systems and tools related gaps and barriers identified in the key document review included:

- Lack of data control system leads to poor data quality and inconsistent data formats<sup>13</sup>.
- No government wide performance monitoring system, no existing M&E framework or strategy for adaptation actions<sup>14</sup>.

The key findings on systems and tools from the stakeholder survey (Appendix 2. Stakeholder Survey Results) are:

- 1. There is a need to standardize data collection and reporting through the use of common tools and templates. These templates should be integrated with any existing systems such as the DesInventar database.
- 2. Implementation of any new tools or templates must be supported by experts who have received extensive training. These systems should also capture key lessons learned and track national improvement plans.

#### **Key recommendations:**

- 1. Standardized data collection and reporting tools
  - Develop data collection templates for climate impacts and climate adaptation action reporting.
  - Develop adaptation target tracking database system that includes mechanisms for data processing, archiving and storage.
- 2. Develop training programme and improvement plan
  - Deliver comprehensive training on data collection, processing, management and reporting tools.
  - o Develop national improvement plan and tracking tools.

#### Stakeholder engagement

Collecting data and using it to prioritize and drive action requires stakeholder engagement. This includes data providers as well as data users and encompasses the public, local governments and communities, businesses and other decision makers. The greater the engagement the better (and more useful) the transparency system will be for evidence-based decision-making and the production of reports. Stakeholder engagement involves seeking out key individuals and organizations and offering benefits in exchange for their involvement (e.g. providing data, insights and resources) with the transparency system. Stakeholders engaged in national

policymaking and business decision-making will provide an important link to the wider impacts of climate action and the integration of climate action with national social, environmental, economic and sustainability goals. Stakeholder engagement related gaps and barriers identified in the key document review included:

- Lack of monitoring and reporting systems to communicate results of adaptation measures to decisionmakers and improve implementation by evaluating lessons learned<sup>15</sup>:
  - There is no government-wide performance monitoring system, nor an existing M&E framework or strategy for adaptation actions.
  - , The lessons learned from previous adaptation planning processes have not formally informed future iterations.

The key finding on stakeholder engagement and communication from the stakeholder survey (Appendix 2. Stakeholder Survey Results) is:

Data is made available to the public and decision makers on request but as discussed above, a lack of
capacity at local level limits communication and coordination on adaptation needs and investment
requirements.

#### **Key recommendation:**

1. **Develop communication plan** to coordinate regular, schedule communication on progress, challenges and needs for adaptation impact tracking.
